Director's Corner

Population Overgrowth

We are, as I write this, in a crisis of a post pandemic population overgrowth of companion animals. During the pandemic, many people adopted cats and dogs. Some of it was out of boredom, some because they were at home more and they wanted to add a furry family member. Many backyard breeders and puppy mills saw peoples' interest in adopting during the pandemic as an opportunity to ramp up their "production" of puppies. Now, with the change in the economy and people returning to work, we, along with many other rescues and Humane Societies have found ourselves flooded with calls for help with them.

It used to be uncommon for our facility to have more than one litter of puppies at a time. In fact, often we didn't have puppies available for adoption. Now, there have been times where we have had over 60 puppies in our care! On top of that, we help our local animal control with dogs. There are very few rescues in the area who will take large dogs, particularly Pitbull mixes, and we just can't say no to them. Because those dogs are in dire need, we can't take the fluffy or little dogs the other rescues have available for adoption.

Every day, we are inundated with calls from people wanting to release a dog or a cat to us, calls from other rescues asking if we can take animals from them, or requests to take a litter of puppies that are no longer wanted from a puppy mill. It is very stressful! I am sure you can imagine how hard it is to have to say no to an animal in need! We do try to prioritize the animals in the direst straits and try to keep a kennel open for an emergency. Prada and her eight puppies are a perfect example of that. Prada was found out running on Highway 14 near Rochester on more than one occasion. It was obvious she had just recently had puppies. Finally, with

the encouragement of animal control, the owner relinquished Prada along with her eight puppies. At that time, we only had one kennel available. It was not an ideal situation, but we squeezed Prada and her eight puppies into that kennel.

We budget for 40 dogs and 80 cats. At one point in the early summer, we had 89 dogs and puppies and 221 cats and kittens in our care! That is why you often find us begging for kitten and puppy food, cat litter and other supplies. We really do try to stay within our budget and with the help of our supporters, we've been able to make that happen. Adding more cats and dogs to our roster isn't a solution. We need people to advocate for spaying and neutering and working to shut down puppy mills that produce thousands of puppies in often horrible conditions every year. We invite MnSnap down every month to help with low-cost spaying and neutering cats and dogs. We alter all our cats and dogs before adoption, but It's not enough. We need people to see the suffering and to help solve the problem. So, I ask of you, whenever you can, please be a voice for the voiceless.

All the animals in the classes are available for adoption, and at least one puppy found a forever home

by being a good yoga partner! All funds collected from ticket sales go to PCHS. In addition to fundraising and adoption, the classes may lead to participants volunteering with or helping to advocate for our animals. If the idea of stretching your mind and body while sharing your mat with adorable adoptable animals interests you, keep an eye on our Facebook page for any future classes. The classes are intended for adults, but we have found that well-behaved older children can also benefit.

Acclimating Your New Cat



When you adopt a new cat, you often have a vision of how your life will be – cuddling, playing, a happy companion for your life. The key to this happy vision is allowing the cat or kitten to settle in.

When you take them home, they have a whole new environment to get used to, as well as new people. She will need time to adjust to her new surroundings. He may be timid and want to hide. Their time in the shelter has been in a space much smaller than your home. To minimize them feeling overwhelmed, confine them to a room or portion of your home for a few days, slowly giving them more space. Similarly, keep their cat box in their space, and move it to its final location (if different) over the course of a week or so, as their familiarity with the home increases. Especially with a young kitten, you want it to be able to be successful in finding that cat box!

Your cat may not be playful or cuddly when they first come home. They may hide or hiss. Let them move at their own pace, and they will approach you when they feel safe and ready. You might be

able to get them to interact using treats or toys. Your cat likes to be in control of itself and its surroundings – allowing them autonomy leads to an easier transition.

If you have other pets, keep them away from your new cat in the beginning. You can allow some sniffing through a door or some controlled meetings after they have been home for a while - how long depends on how they are adjusting. There may be some hissing and posturing between your new cat and your resident cat as they figure out their relationship. It can be stressful for you to see, but it is natural. Separate them again if needed and give plenty of attention to them both! If you have a dog, make sure the dog is leashed or restrained on first introductions, and make sure the cat has ways to escape from the dog - a cat tree can be an ideal getaway.

Your new cat will adjust to you, your home and your schedule. It takes patience – sometimes a lot! Once you allow your new feline roommate to settle in, you are in for a lifetime of love!

Record Event!

ach spring, Paws and Claws holds a HUGE rummage sale. We collect pet-related donations all year long. The items we can't use for our animals are cleaned, repaired, and made ready for our rummage sale. This year, by the time the rummage sale rolled around, we had our garage completely full of boxes packed with pet items, extra kennels, used cat trees, and much, much more. On May 27, a group of dedicated (and very strong!) volunteers loaded it all up and hauled it over to the Olmsted County fairgrounds. Starting the following day, we opened the doors to the big horse barn at the fairgrounds and started taking donations and unpacking everything we had brought from the shelter. Six days were spent sorting, marking, and organizing things for the sale. By the time the sale rolled around on the morning of Saturday June 3, a line to get in our rummage sale wrapped completely around the building! We lost count at over 200 people



waiting in line to come see all the bargains and shop. The sale included household goods, tools, furniture, books, linens, pet items, and more! The rummage sale is a lot of work, but it is done with camaraderie, and with our animals in mind. When we got done counting all the quarters, bills, and checks from the many purchases, we ended up netting over \$27,000! This is a record! It is hard-earned money that will be going to help us open our doors to more animals. Thank you to our devoted co-chairs, Carol Fealey and Annette Durham. They run a tight ship, and it paid off big time! See you next year!

Volunteer Spotlight: Kristi Ziegler

Paws and Claws usually sends a few adoptable cats, and this year they sent a bunch of cats and kittens in strollers, backpacks and playpens. Finally, cats could relax and enjoy the park without dogs! Cat owners also brought their furry friends – a few of them PCHS alumni. Many walkers came to turn in their pledges, visit the

vendor booths, and enjoy a hotdog before taking a walk, led by Ted Schmidt and Jess Abrahamson from KTTC. It wasn't a totally dog-free event – there was a demonstration by a K-9 team from the Olmsted County Sheriff.

Our top pledge earners were Pat Dee in the Adult division with over \$2,600, and Zoey Johnson in the Youth division, raising over \$2,000! Thanks to the generosity of the participants, the community and the sponsoring businesses, the Pet Walk raised over \$37,000 for the animals in our care! This is one of our major fundraisers of the year and will really help the animals in our care. Thank you again to our sponsors and all who participated.

Hank & Artie




